- 1,733,432 shares of common stock, \$0.001 par value per share ("Common Stock"), of Liquidia Corporation (the "Registrant") were automatically added to the shares authorized for issuance under the Liquidia Corporation 2020 Long-Term Incentive Compensation Plan (the "2020 Plan") on January 1, 2021 pursuant to an "evergreen" provision contained in the 2020 Plan. Pursuant to such provision, on January 1 of each year through 2030, the number of shares authorized for issuance under the 2020 Plan is automatically increased by a number equal to four percent of the outstanding shares of Common Stock as of the end of Registrant's immediately preceding fiscal year, or any lesser number of shares of Common Stock determined by the Board of Directors or Compensation Committee of the Registrant. In addition, pursuant to Rule 416(c) under the Securities Act of 1933, as amended (the "Securities Act"), this Registration Statement on Form S-8 (this "Registration Statement") also covers an indeterminate number of shares of Common Stock which may be offered or sold pursuant to the 2020 Plan by reason of stock splits, stock dividends or similar transactions effected without the receipt of consideration which results in an increase in the number of outstanding shares of Common Stock of the Registrant.
- (2) Estimated solely for purposes of calculating the registration fee pursuant to Rule 457(c) and (h) of the Securities Act. ### **EXPLANATORY NOTE**

This Registration Statement on Form S-8 (this "Registration Statement") is being filed for the purpose of registering an additional 1,733,432 shares of common stock, \$0.001 par value per share (the "Common Stock"), of Liquidia Corporation (the "Registrant") that were added to the shares authorized for issuance under the Liquidia Corporation 2020 Long-Term Incentive Compensation Plan (the "2020 Plan") for which a Registration Statement on Form S-8 relating to the same employee benefit plan is effective.

On November 18, 2020, the Registrant filed the Registration Statement on Form S-8 (File No. 333-250179) with the Securities and Exchange Commission (the "Commission") to register, in addition to an aggregate of 2,627,791 shares of Common Stock underlying outstanding stock options and restricted stock units issued under the Company's legacy equity incentive plans which were assumed under the 2020 Plan, 1,700,000 shares of Common Stock that were authorized for issuance under the 2020 Plan (the "Prior Registration Statement"). Upon the effectiveness of this Registration Statement, an aggregate of 3,433,432 shares of Common Stock will be registered for issuance from time to time under the 2020 Plan. Pursuant to General Instruction E to Form S-8, the contents of the Prior Registration Statement are incorporated herein by reference except to the extent supplemented, amended or superseded by the information set forth herein. Only those items of Form S-8 containing new information not contained in the Prior Registration Statement are presented herein.

Any such statement so modified or superseded shall not be deemed, except as so modified or superseded, to constitute a part of this Registration Statement.
